AGREEMENT

This is a contract between Syrotica adult content production and _____ (Model) for the display and sale of images of the Model on/through the Syrotica web sites, and those sites belonging to Syrotica's customers.

Both Syrotica and the Model understand and agree that the images will be adult in nature, and will contain partial to complete nudity and displays of sexuality appropriate for a mature and consenting audience.

RIGHTS

Syrotica is purchasing all rights to images recorded by Syrotica and its staff. Syrotica may, at its discretion, allow Model to use images for their own personal use.

REQUIRED DOCUMENTS

Before being compensated, Model will provide Syrotica adult content production with: 1) 2 copies of valid & legal photo ID, one of which must be government issued (driver's license, passport, etc.) 2) a signed & dated model release, and 3) a signed & dated copy of this contract.

These documents will be retained by Syrotica at its primary location of business for display to any law enforcement agency, or appointed representative thereof, as proof of legal age of Model, in accordance with federal record keeping regulations, section 2257.

COMPENSATION

The Model will be compensated for the time spent recording the images at a rate of \$___ per hour. "Time recording images" does not include Model travel time to/from shoot, nor any delays caused by Model. Delays caused by Syrotica staff during time set aside for recording images are included, and will be paid.

No compensation will be made without the Model supplying required documents, as detailed above.

The model may receive, but is not guaranteed, the following as additional compensation:

A 6-month pass to the members area of a site to which the content in which they appear has been sold, to view pictures of their shoot

Digital copies of selected shots branded with the Syrotica URL for open distribution.
